- 1 "Number of Full-time Faculty (C)" is the cumulative total number of faculty employed in both the spring and fall semesters.
- 2 Since one faculty member in the College of Asia Pacific Studies resigned at the end of the spring semester, one faculty member in the College of International Management was appointed in the fall semester, and one faculty member in the Center for Language Education was on childcare leave in for the duration of the spring semester, each was only paid one semester's worth of funds (Y100,000).
- 3 One faculty each from the College of Asia Pacific Studies and the Educational Development and Learning Support Center was not contractually eligible for payment.
- 4 Since one faculty member in the College of International Management (who resigned at the end of the spring semester) was on leave and one faculty member in the College of Asia Pacific Studies did not meet the requirements for disbursement, funds were not paid to these faculty members.
- 5 As per university regulations, Lecturers in the Center for Language Education are not eligible for payment.
- 6 Regarding the one specially-appointed faculty member in the Center for Language Education and the one specially-appointed faculty member in the Educational Development and Learning Support Center, educational development program allowances are disbursed instead of individual research allowances. (These are not included in the research allowances above.)
